VETERANS' CORNER

I am asking for articles of interest for veterans, from either retirees or those who served. Please send them to me by USPS or email, and I will publish them in future newsletters. I have a copy of **Federal Benefits for Veterans and Dependents, 2006 Ed.**, and have published some excerpts from it. It is very boring reading and filled with "governmentese" making it, for most of us, unintelligible.

NRPC Online Records Request Update

The National Personnel Records Center (NRPC) makes it easier for veterans with computers and Internet access to obtain copies of documents such as their DD-214s from their military files. Military veterans and the next of kin of deceased former military members may use NRPC online military personnel records system to request documents.

The web-based application was designed to provide better service on these requests by eliminating the records center mailroom processing time. Also, because the requester will be asked online to supply all information essential to NRPC to process the request, delays that normally occur when NRPC has to ask veterans for additional information will be minimized. The application may be accessed at <http://vetrecs.archives.gov>

Users will be required to complete the application online and then download a signature verification document that must be signed and mailed to NRPC WEB, 9700 Page Avenue, St. Louis, MO 63132-5100 or faxed to (314) 801-9049 within 30 days. If NRPC does not receive your signature within 30 days, your request will be automatically deactivated and removed from their system.

A service request number will be provided for follow up to (314) 801-0800, if necessary. Other individuals with a need for documents must still complete the Standard Form 180 which may be downloaded from the web at <http://www.archives.gov/st-louis/military-personnel/standard-form-180.htm> or <http://vetrecs.archives.gov>

2010 Reunion

Sunday, October 31 to Thursday, November 4, 2010

The 2010 reunion will be held at the Airport Radisson Hotel in North Charleston, South Carolina and hosted by Tom and Carole Norman.

The room rate is \$79 per night, and will be honored 3 days prior and 3 days after the reunion dates. Tom has reserved a block of 40 rooms for our reunion. Each room has a microwave, refrigerator, high-speed Internet access, coffee maker, iron & ironing board. There is an indoor pool, sauna & whirlpool, and on-site fitness center.

The Radisson is located at 5591 Rivers Ave. North Charleston, SC 29406, <tel:843-744-2501>. To ensure the \$79 rate, you must identify yourself as being with the USS Massey group. **Reservations at the group rate must be made by October 1, 2010.** Reservations made after October 1 will be on a space-available basis and at normal rates. Parking at the Radisson is free.

The Radisson Restaurant provides a Breakfast Buffet (depends on house count) \$6.95, Lunch Buffet \$7.95 and Dinner Buffet (depends on house count) \$8.95.

For those flying in: the Radisson is approximately 3 miles from Charleston International Airport. The Radisson provides complimentary shuttle buses.

For those driving in: from I-95, take I-26 East for approximately 42 miles, exiting at 211A, then turn left on Aviation Ave. Go less than ½ mile to stop light, turn right on Rivers Ave., then turn right into Radisson parking lot.

Area Campgrounds: KOA Kampground, 9494 US-78, Ladson, SC 29456, Phone 843-797-1045, approximately 7 miles from Radisson.

Oak Plantation Campground, 3540 Savannah Hwy, John's Island, SC 29455, Phone 843-766-5836, is approximately 15 miles from Radisson.
